## WWLS'S "THE PURSUIT OF THE BEDLAM EXPERIENCE" CONTEST OFFICIAL RULES

A complete copy of these rules can be obtained at the offices of radio station WWLS ("Station"), owned and operated by Cumulus Radio LLC located at , 4045 NW64<sup>TH</sup> Suite 600, Oklahoma City, OK 73116, during normal business hours Monday through Friday or by sending a self-addressed, stamped envelope to the above address.

The Station will conduct the **WWLS** "The Pursuit of the Bedlam Experience" Contest (the "Contest") substantially as described in these rules, and by participating, each participant agrees as follows:

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility. This Contest is open only to legal U.S. residents, 21 or older at the time of entry with a valid Social Security number and who reside in the Station's Designated Market Area ("DMA") as defined by Nielsen Audio, who have not won a prize from the Station in the last 90 days or a prize valued at \$500 or more in the 90 days, and whose immediate family members or household members have not won a prize from the Station in the last 90 days or a prize valued at \$500 or more in the 90 days. Void where prohibited by law. Employees of Cumulus Media, its parent company, affiliates, related entities and subsidiaries, promotional sponsors, prize providers, advertising agencies, other radio stations serving the Station's DMA, and the immediate family members and household members of all such employees are not eligible to participate. The term "immediate family members" includes spouses, parents and stepparents, siblings and step-siblings, and children and stepchildren. The term "household members" refers to people who share the same residence at least three (3) months out of the year. The Contest is subject to all applicable federal, state and local laws and regulations. Participation constitutes entrant's full and unconditional agreement to these Official Rules and Station's decisions, which are final and binding in all matters related to the Contest. Winning a prize is contingent upon fulfilling all requirements set forth herein.

- 2. Contest Period. The Contest will begin Three hours prior to kickoff (8am CST) on September 15, 2018 and will run through 2 hours after the buzzer signifying the end of the 4<sup>th</sup> quarter of the latter of the University of Oklahoma vs Texas Tech or Oklahoma State University vs Baylor on November 3, 2018 (the "Contest Period"). The Station's computer is the official time keeping device for this Contest.
- 3. **How to Enter.** To enter:
  - (ii) <u>Remote Broadcast</u>: Attend a remote broadcast conducted by that Station and complete an entry form. Limit one (1) entry per person per remote broadcast. All entries must be received 2 hours after the buzzer signifying the end of the 4<sup>th</sup> quarter of the latter of the University of Oklahoma vs Texas Tech or Oklahoma State University vs Baylor on November 3, 2018. The dates of station broadcasts are:
    - September 15, 2018 at The Garage 1117 North Robinson Ave. Oklahoma City, OK. University of Oklahoma vs Iowa State starting 3 hours prior to kick (8am) and ending two hours after the buzzer signifying the end of the fourth (4<sup>th</sup>) quarter;-
    - September 29, 2018 at The Garage 601South Bryant Ave. Edmond, OK. Oklahoma State University vs Kansas starting 2 hours prior to kick (TBD) and ending two hours after the buzzer signifying the end of the fourth (4<sup>th</sup>) quarter;-
    - October 13, 2018 at the Garage 1316 West Covell Road, Edmond, OK. Oklahoma State vs Kansas State starting 2 hours prior to kick (TBD) and ending two hours after the buzzer signifying the end of the fourth (4<sup>th</sup>) quarter;-

- October 20, 2018 at the Garage 2060 South I-35 Service Road, Moore, OK. University of Oklahoma vs TCU starting 3 hours prior to kick (TBD) and ending two hours after the buzzer signifying the end of the fourth (4<sup>th</sup>) quarter;-
- November 3, 2018 at the Garage at 2900 West Britton Road, Oklahoma City. starting 3 hours prior to kick off of University of Oklahoma vs Texas (TBD) or 2 hours prior to kick off of Oklahoma State University vs Baylor starting with the earlier game and ending 2 hours after the buzzer signifying the end of the 4<sup>th</sup> quarter of the latter of the University of Oklahoma vs Texas Tech or Oklahoma State University vs Baylor
- 4. Winner Selection: NO later than 2 hours after the buzzer signifying the end of the 4<sup>th</sup> quarter of the latter of the University of Oklahoma vs Texas Tech or Oklahoma State University vs Baylor. Station will select one (1) entry for the Grand Prize in a random drawing from among all valid entries received by Station during the Contest Period from all remote broadcasts. There will be one (1) Grand Prize Winner and 14 runner-up prizes randomly selected. The winning entrant will be contacted using the email address and/or telephone number provided with the entry and may be awarded the prize (subject to verification of eligibility and compliance with the terms of these rules). Station's decisions as to the administration and operation of the Contest and the selection of the potential winner are final and binding in all matters related to the Contest. Failure to respond to the initial verification contact within three (3) days of notification will result in disqualification. Winner does not have to be present to win. One prize per winner.
- 5. Verification of Potential Winner. THE ELIGIBILITY OF ALL POTENTIAL CONTEST WINNERS IS SUBJECT TO VERIFICATION BY STATION WHOSE DECISIONS ARE FINAL AND BINDING IN ALL MATTERS RELATED TO THE CONTEST. The potential winner must continue to comply with all terms and conditions of these Official Rules, and winning is contingent upon fulfilling all requirements. The potential winner may be notified by email and/or telephone call after the date of random drawing and/or winner determination. The potential winner will be required to sign and return to Station, within three (3) days of the date notice is sent, an affidavit of eligibility and a liability/publicity release (except where prohibited) in order to claim his/her prize, if applicable. A winner who returns the affidavit of eligibility and liability/publicity release will be deemed to have accepted the contest prize and thereafter will not be permitted to rescind their acceptance of the prize and/or return the prize. If a potential winner cannot be contacted, fails to sign and return the affidavit of eligibility and/or the liability/publicity release within the required time period (if applicable), or if the prize or prize notification is returned as undeliverable, potential winner forfeits prize. In the event that the potential winner of a prize is disqualified for any reason, Station may award the applicable prize to an alternate winner by random drawing from among all remaining eligible entries.

Grand Prize. One (1) Grand Prize will be awarded in this Contest. The Grand Prize is 2 Club Level tickets to the football game between University of Oklahoma versus Oklahoma State at the University of Oklahoma Stadium, November 10, 2018. Limo service to and front the stadium provided by Backstage Limo, (the pickup needs to be within a 40 miles radius of the OKC Metro, if further than 40 miles, the Limo service will begin at the PUB W 3720 West Robinson Street, Norman, Ok.) and a \$75 Pub W gift card. ARV [One Thousand Six hundred and Five dollars] (\$1,605.00). Winner is responsible for all taxes associated with prize receipt and/or use. Odds of winning the Grand Prize depend on a number of factors including the number of eligible entries received during the Contest Period and listeners participating at any given time. Runner-Up Prizes. There will be 14: Bud Light Corn Hole Board" valued at \$199.00; "Bud Light Jenga set" valued at \$75.00; "Bud Light Tailgate Grill" valued at \$220.00; (10) ten "Bud Light/ Grizzly 40 quart Coolers" valued at \$225.00 each;

There is no substitution, transfer, or cash equivalent for prizes, except that the Station may, at its sole discretion and to the extent permitted by law, substitute prizes of comparable value or cash. The prizes are expressly limited to the item(s) listed above and do not include taxes, gratuities or any other expenses. Any tickets and/or gift certificates/cards awarded as part of a prize will be subject to the terms and conditions set forth by the issuer and are valid only on the date(s) printed on the tickets or gift certificates/cards. Other restrictions may apply.

The Grand Prize will be selected first, runner up prizes will be selected afterwards in this order, "Bud Light Corn Hole Board" valued at \$199.00; "Bud Light Jenga set" valued at \$75.00; "Bud Light Tailgate Grill" valued at \$220.00; (5) five "Bud Light/OU Grizzly 40 quart Cooler" valued at \$225.00 each; and (5) five "Bud Light/OSU Grizzly 40 quart Cooler" valued at \$225.00 each.

- 6. Entry Conditions and Release. By entering, each participant agrees to: (a) comply with and be bound by these Official Rules and the decisions of the Station, which are binding and final in all matters relating to this Contest; (b) release and hold harmless Station, Cumulus Media Inc., and its subsidiaries, related and affiliated companies, participating sponsors, the prize suppliers and any other organizations responsible for sponsoring, fulfilling, administering, advertising or promoting the Contest, and each of their respective past and present officers, directors, employees, agents and representatives (collectively, the "Released Parties") from and against any and all claims, expenses, and liability, including but not limited to negligence and damages of any kind to persons and property, including but not limited to invasion of privacy (under appropriation, intrusion, public disclosure of private facts, false light in the public eye or other legal theory), defamation, slander, libel, violation of right of publicity, infringement of trademark, copyright or other intellectual property rights, property damage, or death or personal injury arising out of or relating to a participant's entry, creation of an entry or submission of an entry, participation in the Contest, acceptance or use or misuse of prize (including any travel or activity related thereto) and/or the broadcast, exploitation or use of entry; and (c) indemnify, defend and hold harmless the Released Parties from and against any and all claims, expenses, and liabilities (including reasonable attorneys' fees) arising out of or relating to an entrant's participation in the Contest and/or entrant's acceptance, use, non-use or misuse of the prize.

All those who win a prize or prizes valued \$600 or more in any given year will be issued an IRS Form 1099 to report their winnings.
- 9. **General Conditions.** Station reserves the right to cancel, suspend and/or modify the Contest, or any part of it, if any fraud, technical failures or any other factor beyond Station's reasonable control impairs the integrity or proper functioning of the Contest, as determined by Station in its sole discretion. Station reserves the right in its sole discretion to disqualify any individual it finds to be tampering with the entry process or the operation of the Contest or to be acting in violation of these Official Rules or acting in an unsportsmanlike or disruptive manner. Any attempt by any person to deliberately undermine the legitimate operation of the Contest may be a violation of criminal and civil law, and, should such an attempt be made, Station reserves the right to seek damages from any such person to the fullest extent permitted by law. Station's failure to enforce any term of these Official Rules shall not constitute a waiver of that provision.
- 10. **Limitations of Liability.** The Released Parties are not responsible for: (1) any incorrect or inaccurate information, whether caused by Station, entrants, printing errors or by any of the equipment or programming associated with or utilized in the Contest; (2) technical failures of any kind, including but

not limited to malfunctions, interruptions, or disconnections in phone lines or network hardware or software; (3) unauthorized human intervention in any part of the entry process or the Contest; (4) technical or human error which may occur in the administration of the Contest or the processing of entries; or (5) any injury or damage to persons or property which may be caused, directly or indirectly, in whole or in part, from entrant's participation in the Contest or receipt or use, non-use or misuse of any prize. No more than the stated number of prizes will be awarded. In event that a production, technical, programming or other error causes more than stated number of prizes as set forth in these Official Rules to be claimed, Station reserves the right to award only the stated number of prizes by a random drawing among all legitimate, unawarded, eligible prize claims.

- 11. Disputes. Entrant agrees that: (i) any and all disputes, claims and causes of action arising out of or connected with this Contest, or any prizes awarded, shall be resolved individually, without resort to any form of class action; (ii) any and all disputes, claims and causes of action arising out of or connected with this Contest, or any prizes awarded, shall be resolved exclusively by the United States District Court or the appropriate state court located in the Station's listening area; (iii) any and all claims, judgments and awards shall be limited to actual out-of-pocket costs incurred, including costs associated with entering this Contest, but in no event attorneys' fees; and (iv) under no circumstances will entrant be permitted to obtain awards for, and entrant hereby waives all rights to claim punitive, incidental and consequential damages and any other damages, other than for actual out-of-pocket expenses, and any and all rights to have damages multiplied or otherwise increased. SOME JURISDICTIONS DO NOT ALLOW THE LIMITATIONS OR EXCLUSION OF LIABILITY FOR INCIDENTAL OR CONSEQUENTIAL DAMAGES, SO THE ABOVE MAY NOT APPLY TO YOU. All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, or the rights and obligations of entrant and Station in connection with the Contest, shall be governed by, and construed in accordance with, the laws of the state in which the Station is located, without giving effect to any choice of law or conflict of law rules (whether of the state in which the Station is located or any other jurisdiction), which would cause the application of the laws of any jurisdiction other than the state in which the Station is located.
- 12. **Entrant's Personal Information.** Information collected from entrants is subject to Station's Privacy Policy, which is available on the Station's website under the "Privacy Policy" link. All entry blanks, forms, devices, and materials gathered during the course of entry, as well as all information contained therein, shall become the sole property of Station to be used, disposed of or destroyed in its sole discretion. Station is not responsible for any incorrect or inaccurate information entered by website users, and assumes no responsibility for any error, omission, interruption, deletion, defect, delay in operation or transmission, communications line failure, theft or destruction or unauthorized access to Station's website.
