## WWLS'S "TWIN PEAKS FANTAST LEAGUE PARTY GIVEAWAY" CONTEST OFFICIAL RULES

A complete copy of these rules can be obtained at the offices of radio station WWLS ("Station"), owned and operated by Cumulus Media Holdings Inc. or one of its subsidiary companies, 4045 NW 64th Suite 600, Oklahoma City, OK 73116, during normal business hours Monday through Friday or by sending a self-addressed, stamped envelope to the above address.

The Station will conduct the **WWLS "TWIN PEAKS FANTASY LEAGUE PARTY GIVEAWAY"** Contest (the "Contest") substantially as described in these rules, and by participating, each participant agrees as follows:

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

(Winner Selection. On or about 10:00 am CT each Wednesday beginning July 31 through Dec. 25 2019, Station will select one (1) entry for the Grand Prize in a random drawing from among all valid entries received by Station during the Contest Period. The winning entrant will be contacted using the email address and/or telephone number provided with the entry and may be awarded the prize (subject to verification of eligibility and compliance with the terms of these rules). Station's decisions as to the administration and operation of the Contest. Failure to respond to the initial verification contact within three (3) days of notification will result in disqualification.
